5. Bidder proposes to furnish all labor, materials, equipment, machinery, tools, transportation, supplies, services, and supervision for the work described as follows:

Reconstruction of Buildings A and C

Building A (including K Wing) – 54,060 square feet, including classrooms, offices, restrooms, kitchen and cafeteria. Includes repairing two sections of block wall in cafeteria that collapsed. Include HVAC, plumbing, electrical, sprinkler (fire suppression) system, any required fire system repairs/upgrades. Finishes: Carpet squares, VCT tile, Cove Base, Drywall and FRP, ACT/Ceiling, Lights, Paint, Doors/Hardware, Trim, Windows/Glass, plumbing fixtures.

Building C – 19,096 square feet, including classrooms, offices, restrooms. Include HVAC, plumbing, electrical, any required fire system repairs/upgrades. Finishes: Carpet squares, VCT tile, Cove Base, Drywall, ACT/Ceiling, Lights, Paint, Doors/Hardware, Trim

Exteriors – For Buildings A and C, exterior repairs and paint, gutters.
