Include HVAC (mini-split units preferred except in cafeteria), sprinkler (fire suppression) system, any required fire system repairs/upgrades. Must include any required engineering/plans.

HVAC for Building C

Building C – 19,096 square feet, including classrooms, offices, restrooms. Include HVAC (mini-split units preferred), must include any required engineering/plans.
